As a result of the filer's limited proportionate interest in the Trust, his interest in the bulk of the transactions involving the Trust (either additions or deletions) are below the reporting threshold of \$1000 for submission of 278T transaction reports. So the listing of underlying assets set out in this Report may change from prior years as a result of either changes in value of the assets or additions or deletions to those assets below the reporting threshold, rather than asset purchases, sales or exchanges exceeding the reporting threshold.

Summary of Contents

1. Filer's Positions Held Outside United States Government

Part 1 discloses positions that the filer held at any time during the reporting period (excluding positions with the United States Government). Positions are reportable even if the filer did not receive compensation.

6. Other Assets and Income
